UNIVERSITY CODE OF STUDENT CONDUCT

The Office of Community Standards and Title IX supports the Jacksonville State University mission by remaining student centered and educational in its disciplinary procedures. The Code of Student Conduct (https://www.jsu.edu/community-standards/code-of-studentconduct.html) is a way for the University to publicly expect all students (undergraduate, graduate and non-degree seeking) to maintain standards and respect for the University community. Jacksonville State University's conduct system has authority in all non-academic disciplinary matters. The University reserves the right to discipline students and recognized student organizations for acts of misconduct wherever they occur. The University, at its discretion, may pursue disciplinary action against a student while the student is also subject to criminal proceedings. As a Jacksonville State University community member, students are expected to uphold and abide by all local, state, federal and international laws. Referrals received from any University or police authority, regardless of location, are subject to the possible Code of Student Conduct proceedings for the accused.

Sex Based Harassment and Misconduct Policy

(Including Grievance Procedure)

Jacksonville State University is committed to maintaining a safe campus community where all can feel secure and free from sexual harassment, discrimination and misconduct in the classroom, social environments, recreational environments, residential environments and in the workplace. With this in mind, all members of the JSU community are expected to adhere to the requirements of the law, to the standards set forth in this policy and to other conduct related codes of conduct.

This policy seeks to provide the JSU campus community a clearly articulated set of behavioral standards, common understandings of definitions and key concepts, and descriptions and examples of prohibited conduct.

This policy further intends to provide for proper recourse for those individuals whose rights have been violated and appropriate procedures for investigating and determining the outcome of any such complaint. This policy will also provide the enforcement procedures utilized

in implementing this policy balance the rights of complainants, respondents, and witnesses.

Scholars Code

The University recognizes that the open exchange of ideas plays a vital role in the academic endeavor, as often it is only through discussion with others that one is fully able to process information or to crystallize an elusive concept. Therefore, students generally are encouraged to engage in conversations with their teachers and classmates about their courses, their research, and even their assignments. These kinds of discussions and debates in some ways represent the essence of life in an academic community. Even so, it is important for all scholars to maintain academic integrity in all aspects of their work, clearly noting when they have relied upon or incorporated the work of others.

To ensure academic honesty and provide support for students who may have engaged in minor violations, the university proposes the Scholars Code as means by which the course instructor can work with students in an educational and restorative manner while also securing the academic integrity of the University.

This policy emphasizes several values in order to provide students a clear path forward if they have committed an offense and to provide faculty with clear steps to follow when a student has committed an offense in their class. The first of those values is the student's academic responsibility, followed by values impacting the process through which an offense is adjudicated: nondiscrimination, equal and consistent treatment, confidentiality, and respect. To that end, the policy consists of the following aspects:

- Violations
- · Levels of offense
- · Procedures and standards for course instructor reporting
- · Process
- · Levels of sanction based on offense
- Appeals process

This policy is not intended to supersede any departmental or collegelevel policies but to provide a consistent view of academic dishonesty and a practice to follow for course instructors in reporting incidents of academic dishonesty and in initiating the formal adjudication process on the university level.
